
1. Detailed travel logs and mileage reports that document the attorney general's travels by ground and air. Please include the following information:

 - o The duration of each trip
 - o The mileage accumulated during each trip

For each document requested above which you believe constitutes a "closed record" or product of a "closed meeting," please provide as relevant the following:

- a. The date of the document or other record;
- b. The date of the closed meeting(s);
- c. Information required under § 610.023.4, RSMo.

I request that all fees for locating and copying the records be waived.


